Greater Manchester Police Press Release Approved by the High Court 7th December 2010

Increased Concerns for Abducted Child

UK Greater Manchester Police and Toronto Police Service of Canada are appealing for help from the public in tracing a 6½-year-old girl following new concerns for her safety and welfare.

Pearl Rose GAVAGHAN DA MASSA (born 06/04/2004) was removed from Manchester UK on 9 December 2008 by her mother Helen GAVAGHAN (born 14/06/1977). A UK arrest warrant and extradition warrant has been issued for the mother.

The pair flew from Manchester to Tulum, Mexico and crossed Mexico and the USA on foot during December 2008. The mother holds a passport in the name of Meta INTERNATIONAL.

In February 2010 the pair were identified living within an alternative community in Toronto Canada, but police were unsuccessful in detaining them. The mother was known in Toronto as Dana FLAHERTY and Pearl as Belle FLAHERTY. The mother may have been offering unofficial childminding services in the Riverdale area of Toronto with assistance from an unknown business partner.

Concerns grew recently since a healthcare professional came forward to offer new information about Pearl who, in September 2009, was showing clear signs of trauma, social isolation and continued upheaval.

Pearl was in need of medical attention at the time of the abduction in December 2008 and it is strongly felt that she will not have been taken to a doctor since that time. It is understood that Pearl is also not receiving a formal education.

Helen is described as 5' 5" (165cm) tall of very slim or thin build. She has green/brown eyes and had long black hair, which may now be dyed and/or cut short. Helen is described as having prominent angular nose and wide ears.

Pearl is described as 3' 7" (108cm) tall although she will have grown in the last 2 years. She was of normal build with green/brown eyes. She was last seen with light brown shoulder length hair.

Detective Inspector Colin Larkin of South Manchester CID said: "It is two years since Pearl was removed from England and I am increasingly concerned for her well-being as a result of information received from a Toronto healthcare professional who came into contact with Helen and Pearl over a period of months. These serious concerns for Pearl are already over a year old.

"Our aim is to return Pearl to safety and security and if any member of the public has information about this child's whereabouts or has any knowledge of Helen and Pearl whatsoever I urge them to now contact Greater Manchester Police or Toronto Police, in confidence if necessary."
